**ACCES-VR –** Adult Career & Continuing Education Services – Vocational Rehabilitation – Assists individuals with disabilities to achieve and maintain employment and to support independent living.

ADA- Americans with Disabilities Act

BIP - Behavioral Intervention Plan

CAB - Consumer Advisory Board - (for Willowbrook class)

**Care Coordination –** Oversight of services combining developmental disability services and supports with health, behavioral health and wellness services.

**Care Manager (CM) –** A person who coordinates and arranges for the provision of needed services in accordance with goals contained in an individual's Life Plan.

**CAS –** Coordinated Assessment System – An assessment tool specifically tailored to capture the unique health and support needs of individuals with I/DD in New York State.

CBVI- Commission for the Blind and Visually Impaired



#### **CCO –** Care Coordination Organization

**CCS** – Care Connection Specialist – Specific to LIFEPIan CCO – Cover enrollment activities and referrals in all 38 counties.

CH- Community Habilitation

**CI-** Community Inclusion

CMS- Center for Medicare and Medicaid Services

**Circle of Support**- Often used interchangeably with Interdisciplinary Team (IDT) – a group of people decided by the member who help support them in their decision making related to their services. This includes the Care Manager, Service Providers and Natural Supports.

**DC-** Developmental Center

DD- Developmental Disability or Dual Diagnosed

**DDP-2** – Developmental Disability Profile – a questionnaire used to provide an accurate and thorough description of the skills and challenges of a person with developmental disabilities that are related to their service needs.

**DDRO –** Development Disabilities Regional Office (The Office of People With Developmental Disabilities is divided among 5 regions, which cover New York State. Families will interact with the DDRO that oversees the county they reside in.

**IDT**- Interdisciplinary team – often used interchangeably with Circle of Support/Care Planning team – Team of individuals who participate in the person-centered planning process and the development of an individual's Life Plan. The team must be comprised of the individual and/or family, Care Manager, primary providers of developmental disability services and other providers either as requested by the individual and their family member/representative

IEP- Individualized Education Program

IPOP-Individualized Plan of Protective Oversight

IRA - Individualized Residential Alternative

IRMA- Incident Report Management Application

**ISS -** Individual Supports and Services

ISP - Individualized Service Plan, which has been replaced with a "Life Plan"

**LCED –** Level of Care Eligibility Determination – document required to maintain eligibility of services

LD- Learning Disability

LRE- Least Restrictive Environment

Life Plan – Prescription of services that explain the individuals' wants, needs, goals and services. (formally known as ISP)

**RSA –** Request for Service Access – A form used by Care Managers to request services for a member new to HCBS Waiver services

**RSFO-** Revenue Support Field Office

**RVP-** Regional Vice President – LIFEPlan CCO has a Vice President of Care Management for Each of LIFEPlan CCO's six regions, who oversees the Care Manager Directors, Associate Directors and Supervisors in the region.

**SARF –** Service Amendment Request From – A form used by Care Managers to submit to OPWDD to request add additional waiver services for a member, increase the service amount or indicate a change in provider of a waiver service.

**SD-** Self-Direction

SEMP- Supportive Employment Medicaid Program

- **SNAP –** Supplemental Nutrition Assistance Program
- SSA- Social Security Administration

**SSI –** Supplemental Security Income

SSDI - Social Security Disability Income

**Staff Action Plan (SAP) –** detailed plan completed by habilitation service providers (Residential, Day Hab., Community Hab., Pathway to Employment, Prevocational Services and Supported Employment (SEMP)) to help the member reach habilitation goals/valued outcomes through habilitation provider assigned goals identified in the member's Life Plan.
